## **1 - INTRODUCTION**

In occasion of the 150th anniversary of the “dies natalis” of John Mary Vianney, the patron saint of parish priests worldwide, Pope Benedict XVI inaugurated a “Year for Priests” in June. His Holiness described this year as a time for all priests to deepen their commitment to interior renewal for the sake of a more forceful and incisive witness to the Gospel in today’s world.

The “Year for Priests” will conclude in 2010 with the International Meeting of Priests that has the theme “Fidelity of Christ, Fidelity of the Priest.”

This Meeting that will include moments of prayer, reflection and sharing, as well as an audience with His Holiness in St. Peter’s Square, will be developed alongside the religious-cultural itineraries of Christian Rome.

Promoted by Congregation for the Clergy, the Meeting of Priests’ technical-logistical organization has been assigned to Opera Romana Pellegrinaggi (ORP), which has from 1996 handled all the other International Meeting of Priests, such as Fatima [Portugal], Yamoussoukro [Ivory Coast]. Guadalupe [Mexico], Nazareth, Bethlehem and Jerusalem [Holy Land], Rome [2000 Jubilee Year] and lastly Malta.

ORP will be pleased to count on your presence for this upcoming International Meeting of Priests as we believe that “*walking together*” in Christian Rome will help to make this experience more significant, stronger and profound.

Please remember that citizens of the European Union member states are required to have with them personal IDENTITY CARD.

All other participants will need PERSONAL VALID PASSPORTS with the expire date longer than six months from the departure.

Participants who are not the EU residents are obliged to double check travel norms and regulations regarding entrance to Italy at Italian embassies in their respective home countries.

ALL. I /ORP INSURANCE COVERAGE- Inbound Trips  
8-11 JUNE 2010

#### SERVICES PROVIDED

**Medical consultation.** A telephone line active 24 hours a day with medical professionals ready to offer phone consultation regarding the state of health of the insured person.

**Dispatch of a doctor to the site, or of an ambulance to the closest adequate medical center.** Such coverage becomes active when, following a Medical Consultation, it becomes clear that it is necessary for the insured to undergo a medical visitation.

**Appointment of a specialized doctor abroad.** In the event that the insured, following a Medical Consultation, should require a specialized medical visit, the Insurance will indicate the name of a doctor in the area closest to the insured.

**Repatriation.** In the event that, following an injury or sudden illness, the insured should require transportation to an equipped care centre, the Insurance will arrange for return home in the most suitable manner (by plane, train, or ambulance), if necessary accompanied by medical personnel, up to a limit of indemnity of € 7,500.00. In the event of the death of the insured, the Insurance will arrange for and carry out the transport of the body to the place of burial in the Country of residence, up to a limit of indemnity of € 5,000.00.

**Repatriation with a relative.** Regarding repatriation, when accompaniment by medical or nursing personnel is not required, the Insurance, together with the insured person, will also provide for the re-entry, to the place of recovery or residence, of a relative requested by the insured, with the same means of transport used by the insured. Coverage does not include the relative's food and lodging expenses.

**Re-entry of the other insured persons** (by train or plane) when, in the case of Repatriation, the insured persons travelling with the insured person are not objectively able to return home with the means initially foreseen, up to a limit of indemnity of € 200,00 per insured person.

**Travel of a family member who lives with the insured,** to rejoin the insured person who has been admitted to and remained more than 7 days in a Health Centre. Coverage does not include the family member's food and lodging expenses.

**Accompaniment of minors under 15 years** who travel with the insured. When the insured, due to injury, illness or greater force, cannot take care of the minors, the Insurance will allow a family member to join the minors (by plane or train, round-trip), take care of them and bring them back home. Coverage does not include food and lodging expenses of the family member who accompanies them.

**Re-entry of the convalescent insured person** (by train or plane) should, as a result of medical treatment, the insured not be able to return to his place of residence by the means initially foreseen.

**Extension of stay.** Hotel reservations (room and breakfast for a maximum of three days and up to a limit of indemnity of € 40.00 per day for the insured) should health conditions not permit the insured to re-enter on the date established.

**Interpreter at the insured's disposition abroad** should the insured, upon checking in to a hospital, have difficulty communicating with the doctors.

**Coverage of expenses for basic essentials** for which the insured is not able directly and immediately to provide as a result of injury, illness, theft, mugging, bag snatching, or loss of baggage. The Insurance will pay on site, to be later repaid by the insured, expenses up to a maximum sum total of € 5,000.00. In the event that the expenses exceed the total sum of € 150.00, the service will become active once the Insurance has received an adequate guarantee of restitution.

**Curtailment (early re-entry)** of the insured to his/her residence (by train or plane) for grave family reasons (death or hospital admittance, with imminent danger to their life, of a close family member).

**Identification of and information regarding medications** corresponding to the types of medication regularly registered in Italy and available, if existent, on site.

**Advance for bail** to be paid to the foreign Authority, in case of arrest or threat of arrest.

**Legal appointment abroad** in case of necessity of legal assistance following arrest or threat of arrest.

**Communication of urgent messages** to persons residing in Italy.

#### GUARANTEED UNDER INSURANCE

**Reimbursement of medical expenses.** In case of injury or sudden illness, all expenses will be reimbursed by the Insurance for non-deferrable urgent care, received during the trip, such as medical expenses, pharmaceutical or hospital expenses, up to a limit of indemnity of € 1,000.00 for Italy and € 7,500.00 for Europe and Countries of the Mediterranean Basin/World. A fixed deductible of € 35.00 will be applied to reimbursement for each individual accident. The limits of indemnity indicated above include the total of the insured's stays in Health Care Centres prescribed by the doctor up to € 200.00 per day for the insured.

Only in cases of injury are ulterior expenses covered under insurance, for care received after Return Home, as long as they occur within 45 days of the injury.

#### Guarantee of baggage and personal effects.

1. Should the insured suffer material and direct damages as a result of theft, burglary, mugging, bag snatching, loss, misplacement, damages during transport of their own baggage and/or personal effects, including the clothes worn at the time by the insured, the Insurance will reimburse the insured based on the value of the objects, up to a limit of indemnity of € 1,000.00 per insured person.

The limit of indemnity indicated above being fixed, the maximum indemnity for each item, including bags, suitcases and backpacks, cannot exceed the sum of € 150.00. All photographic and video equipment and trappings (camera, video camera, etc.) are considered a single item. The guarantee is valid only if the goods are worn or consigned in deposit in the hotel. The established sum is further reduced by 50% for damages deriving from negligence, loss, or misplacement on the part of the insured.

2. Should the insured, due to delayed baggage exceeding 8 hours relative to the arrival of a duly confirmed airline flight or chartered flight, incur unforeseen expenses for the purchase of toiletries and/or necessary clothing, the Insurance will provide reimbursement up to a limit of indemnity of € 100.00. Excluded from the guarantee are money, cheques, stamps, souvenirs, coins, objects of art, collectibles, sets of samples, catalogues, merchandise, helmet, professional equipment, and documents other than an I.D. card, Passport and driver's licence.

What you read above must be considered just as an additional piece of information.
